Community Manager's Report

Pam Valenza -

- Have collected \$558k for 2007 dues. At the same time last year \$501k was collected.
- Purchased four \$100k repo agreements.

- Redeemed a Cap CD to reimburse the POA.
- Accountants began the audit at their end, will be here next week.
- Met with the insurance agent budget projection was good. Workers Comp may be increased 30% because of one employee's ongoing claim. That was not budgeted for.
- Well 4 job is complete and has been tested.
- Mailed 8 letters to suspected permanent residents. May have two more. One responded.
- State Police were on property looking for a renter.

Discussion held regarding issuing cards for registered renters.

Jo-Ann Pollack – suggested security keeps a separate book for passes for renters.

Pam Valenza –

- Security 1 break-in, 1 citation for no tree permit. Had a lot owner complain that his neighbor cut down trees on his lot; removed his fence and left tire ruts in his yard neighbor sent citations and wants to grieve them.
- DEP was here on Thursday still have a problem with infiltration. Need to work on sewer problems.
- New office no permits yet, contractor needs more information to apply for them.
- Lighting 57 lots with lights left on outside, 9 had lights on inside & outside, 11 had lights inside only.

Discussion held on lighting ordinance. Office will come up with policy and fine schedule for Board to review.

Pam Valenza –

• Campsite Control – 1 letter for Plexiglas violation, 9 holds for the spring.

Legal

Rich Henry –

- Have two pending deedbacks
- One statutory lien to be filed for a property owner that bought 4 lots at tax sale and owes \$20k.
- Fire Brigade filed a 10 day letter to Meier's attorney. Meier offered ½ the money back and to be released from the lawsuit.

President Smith – went around the table and asked opinions from the Board members. Majority vote was for all the money to be paid back.

Rich Henry –

- Arbitration is next stated that Trails End might end up spending more then the \$3,800.00. *Discussion held on the \$3,800.00. Attorney will request the money plus attorney fees.*
- Gave the Township dates for discovery.
- Reviewed the proposed By-Law changes.

- Two outstanding quiet titles cannot get service. Will place notices in newspaper then proceed.
- Sent a second request for the refund of the \$500.00 zoning appeal fee from the Township. No response as of yet.

President Smith – there is a law stating that it is illegal for the Township to charge a non-refundable appeal fee.

Maureen Miller – the Township sent a property owner a violation letter and stated there is a \$600 non-refundable fee to appeal.
