Property Owner Time

- Lot 978 Dead tree on neighbors' property, poses a danger risk. What can be done? Office can send letter to PO about tree being a danger.
- Lot 978 Can PO's submit questions for the board before the next board meeting so they can be discussed at the meeting? Questions may be put in the suggestion boxes or dropped off at the office.
- Lot 3748 Opossum Lane needs work, can it be repaired? Board will send Maintenance to put gravel on the road.
- Lot 2511 Issue with building permit. Water is coming onto open porch. PO needs to go by PA Rule & Building Code. A roll out awning is acceptable.

- Lot 632 No lights are on sign coming into community, can it be fixed. Also, can TE have a community laundry? Explained to PO this cannot be done due to EPA issues and the use of bleach is not good for our water system.
- Lot 5910 Can we get an app on Facebook to advise PO's when water or electric goes out? Security does post issues on their Public Safety page which is an official TE Facebook page. Kevin Dille to look into this matter further.
- Lot 2803 Vandalism at Comfort Stations. PO was advised that it was not vandalism, it was due to individuals sitting on the sinks.
- Lot 1314 In regards to cost of electric, concern is with PO's leaving lights and AC's on when not on property.
- Lot 2719 Security vehicle siren is too loud when going off if speeding. Inquired if a silent speed bum be installed? Public Safety advised PO the use of the siren for speeding will not be used late at night (unless an emergency).
- Lot 3713 Vehicles are avoiding Shohola Parkway and going down Chenango instead (speeding). PO requested the possibility of purchasing an electric sign that also take a picture of the car. PO was advised that the signs are very expensive but can be looked into.

- 635 PO wanted the board to know about a dangerous condition from the water running down the road. The water has made a trench in the road and a golf cart almost flipped in it.
- 635 PO wanted to know and got clarification on quiet hours.
