President Pollack called the meeting to order at 10:15 A.M.

MOTION TO APPROVE September 21, 2024 MINUTES:

Property Owner Time

- Lot #2422
 - PO inquired if having a six-seater golfcart, a vehicle known as a 'Rover', or ATV's that look like golfcarts was allowed in Trails End.
 - In 2025 the rules for golfcarts will be displayed prominently in the Happenings and on the website and there will be no exceptions to the rules.

- Lot #4528
 - PO started a conversation stating he did not believe it was fair for people with electric golfcarts to be 'discriminated' against by having to pay a \$100.00 registration fee rather than \$50.00.
 - It was explained by the Board that it was not due to any discrimination; but rather that it was unfair for any other property owner to have to pay extra in yearly dues because of an extra use of electricity on an individual's property.

- Lot #2208 & 2209
 - PO replied to Lot #4528's previous comment stating that the higher cost of the Golfcart Registration for electric golfcarts was because it would be unfair for the electric golfcarts to expect to be fueled for free while others were paying for their own gas. PO reiterated that higher registration fees are an effort to keep down the price on the yearly dues.

- Lot #3801
 - PO replied to Lot #4528, stating that the raise in price of registration was something that was voted on by the board, but if he wanted to have any change implemented; he could gather like-minded property owners for a petition.

- Lot #4803
 - PO suggested to change the time of the annual meeting due to the inaccessibility of attending due to the fact that the meeting runs after the Executive portion of the Board Meeting. PO suggested it would be more convenient for the meeting to take place on a different day or at an earlier time than the regular board meeting to ensure that more PO's could attend.
 - The Board replied, stating that they would consider different options so that more people could attend.
 - PO expressed concern that she received the Budget letter after the September Meeting and felt that there was not enough time given to have an impact on the result.
