President Smith called the meeting to order at 9:00am. He asked for a Motion to approve the June 2010 minutes.

**Motion:** by Debbie Shevlin to approve the June 2010 minutes. **Second:** JoAnn Pollack. **VOTE:** Abstain: Vinny D'Eusanio, Mark Christie, and Robert Personnette. Approve: All others (Iris Altreche not in room at this time; motion tabled until later in the meeting when it was then approved by 5 of the 8 Board Members with 3 abstentions.)

### **Property Manager's Report**

Pamela Valenza-

• Dues – Still coming in. 5 lots defaulted on payment plans this month but 2 of those lots then paid in full. 8 total out of 32 have defaulted with 5 paying in full. 53 lots still owe 2010 dues & 18 lots still owe 2009& 2010 dues.

• Did an e-mail vote for cameras at compactors and fitness center – cost was \$1,945.00 for the compactor with DVR and monitor, \$1,169.00 for the Fitness Center. Both approved via e-mail. Cameras to be installed Monday and Tuesday of next week.

**Motion**: by Mark Christie to purchase cameras & pay from the Act 180 account. **Second:** Robert Personette **Vote:** Maureen Miller – Yes to Fitness Center & No to Compactors, All others in favor. *Motion Passed*.

- Fire at lot #5925 on June 19<sup>th</sup> after the Board of Directors Meeting. Destroyed a trailer. The fire started in the trailer. There were a minimum of 8 fire trucks on property. Some emergency vehicles were lost in TE. In the future will use flares to direct the fire trucks.
- 911 signs are required under Shohola Township ordinance.
- Sewer Plant the computer processor crashed and the plant was at a standstill. We had a backup processor programmed that Clint Frisbie installed. We now have to buy another one for stock that costs \$4,500-5,000.00.
- Topp Copy Lease is done for copy machine. Have a proposal for new copy machine, same duplicator would stay. Service agreement already paid for the next year so we have this year and next year's maintenance agreement paid.
  \$33.00 a month less. 4 year agreement. Scanning and faxing would be much easier. New Copy machine is \$11,000.00 and \$6,000.00 for duplicator. New machines do not come with a service contract.

**Motion:** by Michael Smith to approve lease for copy machine and duplicator. **Second:** JoAnn Pollack. **Vote:** All in favor. *Motion Passed*.

- Lot #924 sold to adjacent Lot # 925 Now Lot #925 wants to cancel agreement. Will determine legal fees incurred.
- Department of Health was here and inspected the 3 pools on July 15, 2010. No violations Just some resealing to be done on concrete and a skimmer cover to be replaced.
- Roads were tarred and chipped on Yuma, Crow & the upper half of Comanche at the cost of approximately \$26,000.00 for 1.5 miles of road.
- Remax wants to swap Lot #1008 (non-sewerable) with one of our lots #5415. No cost to Trails End, all costs absorbed by Remax of Milford. Lot #1008 to be greened. Discussion.

**Motion:** by Vincent D'Eusanio to exchange lot 5415 with lot 1008 at no cost to Trails End. Lot 1008 to be turned into green area. **Second:** Mark Christie. **Vote:** All in favor. *Motion Passed.* 

- 1466 Lot Inventory Registration forms have been returned, 285 still needed.
- Lot # 5434 would like the monument that used to be in front of the old firehouse. Discussion. **Motion:** by Maureen Miller to put the monument back in front of old firehouse. **Second:** Michael Smith. **Vote:** All in favor. *Motion Passed.*
- Concession is ahead \$4,754.00 from last year in gross income.
- Bar is behind \$740.00 from last year in gross income.
- A property owner suggested making all the spaces handicap parking along the fence of the upper pool. It would be about 7-8 spaces total.
- **Motion:** by Michael Smith to make all parking spots along the upper pool fence handicap parking only. **Second:** Maureen Miller. **Vote:** All in favor. *Motion Passed.*

• Instructed security to check all golf carts for current registration and lights.

- Property Owner Golf Carts with no lights, not registered, and kids driving with security following right behind and no one pulls them over.
- Property Owner July 4<sup>th</sup> a lot of fireworks going off in here. Several calls to security, they were told by security they were too busy.
- Property Owner Daycare center being run from a trailer here in Trails End. There will be fines.
- Property Owner Friday 4 pm security was called to an altercation at the playground between 2 adult women. Security just stood by and watched, never broke up the argument.
- Property Owner Newspaper vendors- can we have them in earlier than 7:00 AM.
- Property Owner Chenango Drive -stone in the pot holes but will they tar and chip. Yes, they are to re-grade road.
- Property Owner Lot #1961 has a rotting deck and electrical issues. Permit from Shohola Township to repair up to 30% of the deck.

- Pres. Smith and Attorney Henry attended another Planning Board meeting Thursday July 15<sup>th</sup>. There will be a public hearing on August 12<sup>th</sup> to adopt the new ordinance at the township meeting permitting open decks to be constructed at Trails End as per the UCC.
- Trails End Structural Compliance Permits to be obtained by property owners for Trails End to inspect before obtaining a permit from Shohola Township. Pres. Smith handed out a preliminary copy of the TE permit for anyone to suggest changes. Board agreed to charge a \$5.00 fee for the permit to try to cover the additional costs.
